SUMMARY

As requested by the Parks and Environment Committee, at its meeting of May 21, 2010, this report provides further information on the cash-in-lieu of parkland payments received from 1998 to 2009 and their distribution amongst the various Parks, Forestry and Recreation Reserve Funds. The distribution of these payments into these accounts is in accordance with Council's approved Cash-in-lieu of Parkland Allocation Policy that was adopted in July, 1999. Attachment 1 outlines the distribution of these funds in the various Parkland Acquisition Reserve Funds. Attachment 2 outlines the distribution of these funds in the Parks, Forestry and Recreation Development Reserve Funds.

DECISION HISTORY

COMMENTS

This report responds to a request by the Parks and Environment Committee, at its meeting of May 21, 2010, for additional information on the amount of cash-in-lieu of parkland payments received from 1998 to 2009, which is the time period that was examined in the May 7, 2010 staff report on the analysis of the parkland acquisitions obtained by the City of Toronto since amalgamation.

Attachment 1 outlines the distribution of cash-in-lieu of parkland payments in the various Parkland Acquisition Reserve Funds that were obtained from development between 1998 and 2009. Attachment 2 outlines the distribution of cash-in-lieu payments in the various Parks, Forestry and Recreation Development Reserve Funds that were obtained from development during this time period. These charts provide a snapshot of funds received as of December 31, 2009. All of the revenues in the Development Reserve Funds have been allocated in the 2010 Parks, Forestry and Recreation approved Capital Budget and Five Year Budget Plan.
