Recreation Services for Youth: Expansion of Youth Spaces

Committee Decision

The Community Development and Recreation Committee:

- 1. Requested Deputy City Manager, Cluster A to develop and maintain a youth-friendly website to improve virtual access to available youth recreation services, programs and initiatives in the City.
- 2. Referred the report (November 20, 2013) from the General Manager, Parks, Forestry and Recreation to the Budget Committee for their consideration on the implementation of 10 new youth lounges based on the model proposed by St. Stephen's Community House and Community Recreation for All, with the option to use 2014 budget allocation to also enhance existing lounges based on the same proposed model, to begin operation by June 1, 2014; and
- 3. Subject to funding being approved in Recommendation 2, the Community and Recreation Committee requested that:
 - implementation include an appropriately resourced Advisory Committee comprised of staff and community members representing youth workers, youth serving agencies, parents, youth and Community Recreation for All and other appropriate organizations, to provide ongoing input on start up and operation of youth spaces;
 - b. the Advisory Committee provide input and assist in evaluation for potential neighbourhoods for new and enhanced centres, including locations in Rexdale, Kingston-Galloway, Jane and Finch, Central Etobicoke (East and West Malls), Mount Dennis, Weston and Lawrence, and Kipling and Dixon; and
 - c. staff report on the current youth programs and the role of the Advisory Committee in 2014;

Origin

(November 20, 2013) Report from the General Manager, Parks, Forestry and Recreation

Summary

In November 2012, City Council adopted the City of Toronto's 2013-2017 Recreation Service Plan (RSP). The RSP will guide the City of Toronto's planning and delivery of recreation programs and services over the next five years. An Implementation Plan was approved in July 2013.

The comprehensive Recreation Services for Youth report was approved by City Council in October 2013. The report included the Youth Recreation Engagement Strategy, an inventory of current recreation programs and services for youth and explored options to expand additional youth drop-in programs and integration with the Toronto Youth Equity Strategy.

This report responds to the follow-up direction by City Council to report back to the Community Development and Recreation Committee on the financial impact and criteria to implement an additional 10 new youth spaces, incorporating an enhanced community recreation youth space model proposed by St. Stephen's Community House and Community Recreation for All. This report was informed through community and stakeholder engagement including St. Stephen's Community House, the United Way, community youth workers and Parks, Forestry and Recreation staff.
