The search by staff of Development & Infrastructure Management (DIM), Parks, Forestry & Recreation, has found responsive records regarding all of the facilities you have indicated.

DIM staff indicate that PO # 6004691 (\$392,449) was issued to WGA Architects for visual auditing of Community Centres only and it only applied to the three Community Centres listed below (not the AIR's):

Wallace-Emerson Community Centre  
McCormick Community Centre  
Bob Abate community Recreation Centre


DIM staff state that the listed Artificial Ice Rink (AIR) locations were visually audited by Accent Building Sciences in November/December, 2001, under Toronto PO # 6005194 and not by WGA Architects, as indicated. At that time, a visual audit of Albert Campbell AIR was completed, the AIR has since been transferred to Corporate Services and no due diligence audit has been completed within DIM mandate.

Access is being granted in full to the records you have requested regarding all of the community centre and AIR locations in both of the above-indicated audits.
